Textual Information(1)	<p>LATE SRI. PARMESWARA RAO GUNDAVELLI and Late Sri. T P Chary held 110200 and 12650 shares respectively which constitutes a trivial percentage of 1.75% of the overall capital. Both were demised on 06.03.2017 and 05.02.2018 leaving behind an unregistered will. Consequently, the legal heirs are in the process of completing the requisite legal formalities to establish their rights over the said shares. As per applicable laws, including the SEBI (LODR) Regulations, 2015, and the procedure prescribed under the Companies Act, 2013 for transmission of securities, transmission can only be carried out upon submission of necessary legal documents by the legal heirs. Since the Will is unregistered, the heirs are required to obtain probate / succession certificate / letter of administration from the competent court to substantiate their entitlement. Therefore, the shares continue to remain in physical form to comply with the legal requirements and to avoid any transmission in the absence of valid proof of entitlement. We confirm that there is no deliberate delay, and the matter is pending solely due to completion of statutory legal processes by the legal heirs.</p>
